

## **Website Terms and Conditions**

Effective Date: July 24, 2025

This website ("Website") is owned and controlled by ShopDonation KR. If you use this Website you agree to the terms and conditions ("Terms and Conditions") set out below. These Terms and Conditions apply whenever you access the site, regardless of whether it is by telephone, computer or other device.

You may not assign, sub-license or otherwise transfer any of your rights under these Terms and Conditions.

Users must not use this site for any purpose or in any way which is contrary to law.

We may amend all or part of the Terms and Conditions at any time. If we do, the new Terms and Conditions will be published on the Website with the effective date. Your subsequent or continued use of the Website will constitute your acceptance of any changes.

### **Definitions**

For the purposes of these Terms and Conditions:

- **"ShopDonation"** refers to the operator and owner of the Website.
- **"Website"** refers to the online platform accessible via [www.shopdonation.co.kr](http://www.shopdonation.co.kr), including all services, pages, and functionalities.
- **"User"** refers to any individual or legal entity that registers for or uses the Website, including but not limited to consumers, retailers/webshops, and charities/nonprofits. All Users must accept these Terms and Conditions to access the services provided by the Website.
- **"Retailer"** or **"Webshop"** refers to any third-party commercial entity offering goods or services through affiliate links on the Website.
- **"Charity"** or **"Nonprofit"** refers to any organization, group, or individual, whether or not officially registered with competent authorities, listed on the Website as a beneficiary of donations.
- **"Affiliate Link"** refers to a unique hyperlink provided through an affiliate program that tracks purchases and commissions.
- **"Commission"** refers to a percentage of a qualifying purchase paid to ShopDonation by the Retailer.
- **"Donation"** refers to the portion of the Commission allocated to a selected Charity.

## **Nature of Service**

ShopDonation.co.kr is a shop-donation platform that allows users to support Charities or Nonprofits of their choice by shopping through Affiliate Links to third-party Retailers or Webshops. We are not a seller, distributor, or representative of the Retailers or Charities listed on the site.

## **Services and purchases**

By ordering/purchasing a service or product through this Website, you support one of the Charities or Nonprofits. We act as an affiliate marketing Website, which means that we receive a Commission for each qualifying purchase from a Retailer who has achieved sales through our Website.

Our system facilitates the Donation amount shown on the Website, which is intended for the Charity, and the entire process is transparent and displayed on our Website and can be monitored and verified on our Website. Our Website transfers the mentioned Donation amount to the Charity only if it really receives a Commission. We do not assume any liability in the 100% accuracy of the published purchase information, since cancellation, stopping or delaying in the above transactions can occur. Furthermore, after making the purchase, you do not have any subsequent rights in terms of controlling or managing assets intended for the Charity.

When the Charity (project) is registered on our Website, it will automatically be placed on all websites under the SHOPDONATION franchise. In this way, the Charity will be able to receive income from multiple countries. Each Charity will be able to generate a unique international SHOPDONATION link and the visitor/customer will be able to choose in which country to make the purchase.

Please note that we do not own or control Retailers and Charities that are presented on our Website, therefore, we take no responsibility for the products, services or activity they provide.

Funds for the Charity are transferred every 3 months and only if they exceed the amount of 30,000 KRW. If these funds do not reach the amount of 30,000 KRW, they are retained until the expiration of the new 3-month period waiting for the 30,000 KRW limit to be reached. In the event that the purchase is cancelled, suspended or delayed for any reason, ShopDonation KR will not receive Commission so there will be no transfer to the Charity.

The Charity (project) may be cancelled by us or by the Charity itself, and afterwards all obligations that ShopDonation KR have are terminated and all information about the Charity (project) on this website will be deleted.

ShopDonation KR retains a portion of the Commission to cover administrative and operational costs, and to support its own commercial activities and business operations. Details may be found on the Website or made available upon request.
